Clerk was asked to reply stating we can only reiterate the comments of the S.C.C. and that as far as we are aware Tarmac are operating within a planning permission.

Mr. Compson reported the railings along Trysull Holloway have not yet been painted. Clerk to find out when this work is to be carried out.

Mr. Compson reported that some items have been taken off the noticeboard in Seisdon Road, Trysull.

Mr. Tonkinson reported that Mr. Unwin had enquired about the hedge along Feishill Road which had been taken out without permission. Clerk to write to Planning requesting hedge be replaced.

Vice Chair reported he has received a complaint about the rubbish left on the Playing Field at Seisdon after football matches. Clerk to write to the Chairman of the Playing Field Association, Mr. Joe Harper, requesting this rubbish be picked up after matches.

The Clerk reported that Mr. Tonkinson has donated book vouchers for the School's painting competition. Clerk to forward these to All Saints School.
