MINUTES OF MEETING

PLANNING APPLICATIONS

04/01418/FUL Two storey side and single storey rear domestic extensions, Manor Farm, Seisdon Road, Trysull.

Parish Council surprised that this building is not listed as it is felt Manor Farm is a supreme example of the arts and crafts movement of which the Mander family were patrons. Parish Council to bring this to the attention of the planners before making any decision and in view of this we request a deferment pending consideration to the status of this building. If unable to defer the Parish Council object to this application.

04/01420/FUL Erection of steel portal frame agricultural machinery store and workshop, Shipley Cottage, Shipley - No objection

04/01353/FUL Detached double garage for private cars in connection with approved bungalow rear Lees House, Park Farm Drive, Trysull - No objection although the Parish Council would question the location of the proposed garage.
