MINUTES OF MEETING

The Minutes of Meeting dated 8th November 2006 were agreed and signed as a true record.

PLANNING APPLICATIONS

06/01287/FUL Demolition of two semi-detached cottages and erection of two detached dwellings, 1 Home Farm Cottage, Crockington Lane - Object to three storey dwellings and on grounds of overdevelopment. Completely out of character with the surrounding area. These cottages should be retained in their present form.

06/01289/FUL First floor side extension, 47 Post Office Road - Objections on grounds of overdevelopment. This dwelling has been extended at least three times. Vice Chair declared an interest.

Mr. Skelton reported he has attended a meeting regarding rural affordable housing and stated that a Rural Housing Enabler would, if asked, attend a Parish Council meeting to speak to Councillors. Councillors to consider this.

It was reported that graffiti has been sprayed in the bus shelter on Ebtree Road and it is now impossible to read the timetable.

The Clerk was asked to invite the Community Beat Officer, PC Dean Colley to our next meeting to discuss several problems in the Parish. Also extend invitation to Inspector Pat Shannaghan.

The Chairman reported there is a meeting at Bobbington Village Hall on Thursday 14th December, 7.30 p.m to discuss policing issues. Chairman to ask if Mr. Southall is able to attend.

The Clerk was asked to request that Ebtree Road be swept from the Smithy to Seisdon Road. There is no pavement and wet leaves are present making it dangerous for pedestrians.

Clerk to write to the Highways stating that the Wombourne Road at the corner of Monkspath is greasy with leaves and needs to be swept for safety reasons, and also School Road, Trysull needs to be swept.

It was reported that the garage at Marchfield is being used as an office. Clerk to inform Planning.

There was concern regarding activity at Stonegate where cars are being stored. Clerk to inform Planning.

Clerk to inform Highways that two trees are down on Trysull Holloway, left hand side half way along, and a tree is leaning dangerously on Seisdon Holloway, left hand side after Tarmac entrance.
