PLANNING APPLICATIONS

07/01117/FUL Extn. and rebuilding garage (amended plans) Brook Cottage, Seisdon Road – Objection that front of dwelling will be too close to Seisdon Road and the proposed porch will be virtually on the highway as there is no footpath. This will cause a highway hazard and will also have an adverse effect on visibility for cars leaving the shared driveway to the west of the proposed extension.
