## **ANY NEW BUSINESS**

The Clerk reported that due to non-attendance of meetings for 6 months Mrs. Sanders ceased to be a Parish Councillor from 15<sup>th</sup> January 2010. Clerk has written to Mrs. Sanders with copies to Mr. S. Winterflood, Mr. Hardy, and Mrs. Robinson at S.S.C., Codsall. Forms advertising a casual vacancy have been filled in and will be put on the noticeboards on Thursday 11<sup>th</sup> February.

Councillor McCardle informed the meeting that Mr. Gavin Williams has been selected as the Tory Candidate. Cllr. McCardle will let us have further details at the next meeting.

Mr. Tonkinson reported that Councillor McCardle will be Chairman of the South Staffordshire Council this year and there will be a Civic Service at Trysull church on Sunday 6<sup>th</sup> June. Mr. Tonkinson asked Councillors to help on the day with parking and directing guests to the church.

Mr. Compson reported that the finger sign on the corner of Crockington Lane and Feiashill Road, by the small triangular green, has broken. Clerk to report to Highways.

Mr. Compson requested a litterpick from Bell Road to the Bratch as there is a large amount of bags, cans etc. There was also a request for a litterpick along the length of Fox Road.

The Chairman stated he has received a letter from Mr. Johns, a resident of Seisdon, regarding the gates on Church Lane and vandalism. The Clerk was asked to reply to Mr. Johns stating that the vandalism has been reported to the Police by the Chairman and the gate on Church Lane remains there solely for the purpose of assisting with the movement of livestock.

Mrs. Lui has spoken to the Chairman regarding the opening of the gate along Church Lane and the Chairman will speak to her.
