PLANNING APPLICATIONS

Mr. Compson declared an interest in both applications.

11/00061/CAC Demolition of workshop (resubmission of 10/00599/CAC The Croft, Trysull – No objection.

11/00060/FUL Conversion of existing barns to two dwellings with associated parking (resubmission of 10/00598/FUL) The Croft, School Road, Trysull - No objection but serious concerns about the line of sight being at the correct length in view of this narrow, busy lane. Request this is reviewed.

Concern about lack of visibility especially in view of a possible 12 – 16 vehicles using this access.

Parish Council concerned to ensure permission has been granted for the access as shown on the application, including Conservation Area Consent and request this is checked.
