NEW HIGHWAY MATTERS

It was reported that Seisdon Road is and has been flooded for several months outside the Manor House, Trysull. Clerk to notify Highways.

Drains at the bottom of Oak Drive blocked and drains in several other locations blocked. It was reported that the Highways visit twice yearly to unblock drains.

Hedge on Fox Road has been reduced in height and trees on the highway verge are now exposed and need trimming and the ivy removing. Clerk to inform Highways.

ANY NEW BUSINESS

Pot holes reported in front of nos. 1 – 4 Rudge Court. It was stated this is an unadopted road and the responsibility of the S.S. Housing Association. Clerk to inform this Association.

The Chairman reported he has received complaints about Church Lane, Seisdon where the access needs repairing. It was stated this is an unadopted road and bridleway and is the landowners responsibility. Clerk to inform complainant.

Play Area

February inspection carried out.

Playing Field, Trysull

Mr. Smith reported he has met with Mr. Graham Hughes to discuss grant funding for the Play Area. Discussions will continue.

The poplar tree on the boundary with Woodford Nursing Home needs to be felled. Paperwork with the SSC.

Pavilion

The Chairman has two letters regarding Activity Angels which will be read out at the appropriate PFA meeting.

1350 **Footpaths**

Footpadders - Mr. Kelly will regenerate the scheme in the Spring.

1477 **Village Hall**

Plans received for disabled toilets. It was reported that there has been refurbishment to the ladies toilets. Cllr. Kelly has requested the minutes recording when this work was authorised.

Trysull School – 20 mph zone
Cllr. Edwards stated that Highways are carrying out a feasibility study regarding the 20 mph zone and this is a priority for this year.
SID's
SID situated on Seisdon Road by the Manor House, Trysull.
Speed limits
It was agreed the Parish Council need reduced speed limits in the Parish. There are very few footpaths and the roads need to be safe for pedestrians, cyclists and horse riders. It was agreed we request a 20 mph limit within the villages, 30 mph limit on Seisdon Road and Crockington Lane, two roads which link the two villages, and 40 mph along Fox Road from Bridgnorth Road to the entrance of Seisdon. The Clerk was asked to write to Gavin Williamson, M.P. and request his assistance in this matter.

Cllr. Edwards offered to speak to the Footpath Department at County Council about the public footpath around the restored quarry.
