PLANNING APPLICATIONS

06/01364/FUL Roof, alteration to garage, boundary wall, Little Thatch, Trysull – No objections. Chairman and Vice Chair declared an interest and did not comment.

06/01415/FUL Demolition of dormer bungalow and replacement with five dwellings, 36 Post Office Road, Seisdon - objections on grounds of overdevelopment, highway danger due to increased traffic and parking on road. Although an effort has been made to improve the street scene, this will not help with the parking problem.

06/01362/COU Change of use to retain building as dwelling, Farmhouse Cottage, Fox Road, Seisdon - No objection although concern at height of proposed chimney.
