08/01210/FUL Erection of three detached dwellings, The Croft, School Road – Mrs. Sanders declared an interest and left the room. Mrs. Bagley declared an interest and did not speak on this application. The Parish Council objected on grounds that proposed development overlooks White Row, access is not suitable for size of development and permission for this access was given for use of the Croft only. It was thought that part of this site is in Green Belt and if this is the case we would object.
08/01193/FUL Erection of detached bungalow, The Summer House - Objections on grounds of Green Belt and that it would be a permanent dwelling. Condition attached to this dwelling that states it is for Mr. Hubball's lifetime only.

Bridlepath 15 - It was reported that the gate Trysull end is locked and landowners cannot access their land. Cllr. Edwards will speak to Mrs. Moore. They are not able to control traffic movements along the lane although they will monitor the site.

Cllr. McCardle will speak with Planners regarding the log cabin and possible unauthorised use.

Footpath 17 - There is no stile by the Mill Pool and the Clerk is to inform Mr. Rochfort we have no objection to the Diversion Order.
