Cllr. N.D. Compson and Cllr. V. Merrick declared an interest in planning application 13/00771/FUL, The Croft, School Road, Trysull, and did not speak on this matter.

**MINUTES OF MEETING**

The Minutes of Meeting dated 11<sup>th</sup> December 2013 were agreed and signed as a true record.

PCSO Adrian Price brought the Parish Council and residents up to date with policing in the Parish. Adrian has been out and about and there has been a leaflet drop regarding rogue traders, four of which have been apprehended by the Police.

The meeting was opened to the residents and Mr. David Southall took the floor expressing his and the residents' concerns about the recent planning application from Tarmac Quarry to extend the timescale for winning and working of sand and gravel. It was agreed the Chairman will formulate a letter and the Vice Chairman will make copies to be delivered to every household in the Parish.

**PLANNING APPLICATIONS**

13/00771/FUL Proposed conversion of barns to two dwelling, office space and parking at The Croft, School Road, Trysull - Objections on grounds that siting of the development would be likely to prejudice the amenity of the adjoining property because it would lead to overlooking and loss of privacy. The proposed shared parking would prejudice the amenity of the adjacent proposed dwelling by virtue of disturbance and headlights.

13/00997/LUE Retention of landing stage and wooden storage sheds, Awbridge Farm, Trysull Objections on grounds development in Green Belt and has detrimental effect on the canal scene and the environment. It is out of keeping with the surrounding area and we question that the landing stage and additional buildings have been present for 4 years.

Appeal for replacement of former cricket club, Wombourne Road dismissed.

#### Oak Drive payment

#### Seisdon Road

#### Wombourne Road

Pot holes are present above the bend by Monkspath on left hand side when travelling from Trysull.

Simon Griffiths (Highways Officer) to report these.

A tree branch is overhanging between Union Lane and Monkspath which is dangerous.

Simon Griffiths to check whether this is a highways tree or in private ownership.

#### Drains, gutters and gullies

The gutters from Bell Road to School Road need cleaning. There is debris and grass growing on them.

Leaves are also blocking the drains along Ebstree Road.

Leaf clearance carried out by District Council. Blocked drains cleared by Highways. Weed spraying will start in May.

All gullies in the Parish need to be inspected and cleaned where necessary. Drains in Post Office Road are blocked.

All gullies are cleaned out as part of a rolling programme which is ongoing. Specific individual gullies that are causing issues is covered by an ad-hoc team and can be reported directly to the Highways Hotline.

#### Fox Road

Trees on the verge need renovating and the rough verge near to the hedge needs tidying up.

#### Overgrown hedge

Junction with Trysull Holloway and Ebstree Road. Cllr.Neil Compson offered to investigate ownership.

#### Bratch Lane, Wombourne

New priority system on Bratch Lane before the bridge. It was felt this is dangerous.

#### Overgrown hedge, Feiashill Road

Clerk to thank resident for cutting the hedge.
