Highways informed.

Mr. Keeling has informed Cllr. Edwards that this narrow area will be concreted.

Signs/road markings, traffic calming areas

It was felt that additional road markings/signs are needed to highlight traffic calming areas. Some signs need attention: Corner Seisdon Road by Meadow Cottage – de-restriction sign is sideways/ Sign at Ebstree Road bridge.

Village Hall - Posts on verge outside Village Hall have been knocked over/damaged.

Highways informed.

Seisdon Road, Trysull - no kerb from the P.C. noticeboard to the Manor House. Highways informed that this is dangerous to pedestrians.

Bridgnorth Road - lights at the Garden Village very distracting and Cllr. McCardle stated he has reported this to Enforcement.

Signs on the highway verge outside Wyevale Garden Centre (formerly Gardenland). Distracting and impeding visibility. Highways informed.

Trysull Holloway - village side of bridge, sluice valve tap cast iron cover is broken in the middle of the road. Highways informed.

Hungerford House, Seisdon Road - deep dangerous pot hole in front of dwelling has been reported to Highways.

Hollybush at Ebstree - large stones have been exposed at the base of the hedgerow past the Hollybush. Very dangerous and cars have been damaged by these. Highways informed.

The Gables, Seisdon Road - overhanging hedge in front of this dwelling is forcing vehicles into middle of road when turning left from Seisdon Holloway into Seisdon Road. Reported to Highways

Meadow Cottage, Seisdon Road - bend sign is covered by the hedge in front of property and cannot be seen. Reported to Highways.

Wombourne Road - Trysull Village entrance sign damaged. Reported to Highways.
