**ANY NEW BUSINESS**

It was reported that a business has expanded from residential premises at Clan Park and over-trading is taking place. It was agreed the Clerk will inform Mrs. Poxon, Planning Department.

It was stated that the hedge along Fox Road from the build-out towards Seisdon needs cutting back further in order that oncoming traffic can be seen. Mr. Unwin felt that the whole length of the hedge up to the top entrance of the poultry farm needs to be cut. Clerk to write to Highways.

A russian vine is growing from the Mill House into the power lines. Clerk to notify Highways.

It was reported that youths are congregating around the bench opposite the Seven Stars and throwing stones at vehicles and hitting golf balls. It was agreed the bench will be taken away for a limited period and a Councillor will speak to the parents. Mr. Tonkinson will arrange for the bench to be taken away.
