MINUTES OF MEETING

The Minutes of Meeting dated 10th June 2009 were agreed and signed as a true record.

Community Action Support Team

The Chairman welcomed Emily Howsam and David Leese to the meeting. They informed the meeting that C.A.S.T. is being supported by the District Council and that they have been distributing surveys to smaller villages in South Staffordshire. The Chairman offered to help distribute surveys to residents in the Parish and this offer was accepted. This CIRCUIT project will be helping to identify gaps in community activities particularly for older and young people in smaller villages.

09/00343/FUL Part demolition of existing two storey garage to trade off for proposed single storey rear kitchen extension and proposed single storey side boot room, Home Farm House, Crockington Lane, Seidon - No objection

09/0048 9/FUL Proposed erection of 1 no. dwelling and 1 no. detached garage block. The proposal is for a detached dwelling and detached single garage block that are amended designs to those previously approved under planning application 08/00578/FUL, 36 Post Office Road, Seidon - No objection.

SS.08/18/628 MW Restoration of former Seidon Landfill site, Ebtree Road, Seidon, Geotechnical Survey and Plans - Objections as stated in previous letter . Strong concerns about control of materials being deposited at the site and if the Council is minded to grant permission then stringent controls must be in place as with Tarmac. There should be cameras to show what is being deposited with supporting documentation from both ends. The site is not a problem and the land is being reclaimed naturally and there is concern that disturbance to this site could have a detrimental effect to this natural reclamation taking place. Validity of the deposition of inert materials is questioned when most of it is recyclable.
