Cllr. Merrick reported the pot hole outside Hungerford House, Seisdon Road, Trysull has not been filled in and is becoming deeper and more dangerous. Clerk to e-mail Mark Keeling with a copy to Cllr. Edwards.

Cllr. Smith discussed our request for a weight restriction on Fox Road and Ebtree Road at the beginning of 2019 with Cllr. Edwards. Costings and possible self funding was discussed. Reply received from Mark Keeling stating he will list our request for action via the County Councillors Divisional Highway Programme in 2017/18 and the information will be entered onto their database. It was reported the 'Give Way' sign at the build-out by the Smithy has been removed and Clerk to request this is replaced.

- 2658 Drains, Ebstree Road
Reply from Simon Griffiths stating work at Ebstree Road and The Holloway should commence week commencing 27th June. Gullies have not been cleaned and Clerk to write again.
- 2660 SID sign on Ebstree Road
Reply received from Mr. Keeling stating it may be feasible to look at installing SID units in the grass verge areas on the junctions or opposite at each end. Cllr. Edwards will speak to Mr. Keeling.

- 2665 Weight Restriction warning signs
Reply received from Simon Griffiths, Highways, stating this will need to be funded and considered via the Local Members Divisional Highway Programme and suggests the Council speaks with Cllr. Edwards and ask him to consider this.
- 2666 Queen's Birthday
The Chairman and Cllr. Tonkinson visited the School and gave the commemorative medals to the school children. The children have made cards thanking the Parish Council and the Clerk was asked to write to the Head Teacher.
- 2667 Rural Crime Initiative
The Clerk reported she has spoken with Cllr. Neil Compson who has reported the application for funding has to be submitted by 14th September and Judith Russon, Partnership Manager of South Staffs LPT, needs the support of the Parish in obtaining 20 names and addresses of interested parishioners. Clerk to ask all Councillors if they will put forward their details and also to e-mail organisations in the Parish asking for support in this scheme.

The Smithy, Seisdon - Awaiting result of discussions with the new owners and Highways.

Wombourne Road (4014672) Bollards broken on bend between Union Lane and Ovens End.

Wombourne Road - Village entrance sign has been added to Cllr. Edwards' DHP for future consideration.

Fox Road - hedge on right hand side by traffic calming when approaching from Bridgnorth Road still needs to be cut back more severely in order to see oncoming traffic.

Post Office Road, manhole cover outside Lilac Cottage, Post Office Road where the tarmac is crumbling and coming away making the manhole cover unstable. Clerk has informed Highways.

Woodford Road, Trysull (Enquiry 40446 25) Pot holes reported. Site has been assessed.

Union Lane, Trysull (Enquiry 4044624) Pot holes outside Awbridge Farm, Flash Lane and Blackpit Lane. Site has been assessed.
