SSC stating Cllr. Maher has been co-opted to the Standards and Resources Committee, SSC. South Staffordshire Open Space Assessment form from Knight Kavanagh & Page who have been commissioned by SSC. Councillors do not agree with survey and cost to SSC and survey will not be carried out. Clerk to forward our concerns.

Oak Processionary Moth report from DEFRA.

Helen Marshall, Community Safety Officer, states the SSC have purchased 5 SIDs, one for each of the 5 localities. Two locations to be registered and the Chairman has forwarded Feiashill Road and Ebstree Road. There will be 1 SID per locality and will only be at a location for 2 weeks and then moved to the next location on the list.

Chairman will speak to Mr. Stevens.

2753 Village Entrance sign, Ovens End

Reply from Diane Firkins to Cllr. Wilson states there is limited space to erect a sign without the sign being hit. Clerk to ask Diane for a site meeting.

2760 Light at Pavilion Garden Centre

Need to ascertain whether light needs to be re-positioned.

Extra funding from County Council for repairing/improving highways.
Cllr. Beardmore has received a quotation to carry out jetting of drains and Cllr.Mrs. Wilson to check whether private contractors are allowed to jet drains.
