**MINUTES OF MEETING**

The Minutes of Meeting dated 14<sup>th</sup> February 2007 were agreed and signed as a true record.

**PLANNING APPLICATIONS**

07/00164/FUL First floor extn. to bedrms, 89 Feiashill Road - No objection

06/01415/FUL Demolition of dormer bungalow and replacement with five dwellings, 36 Post Office Road - Strong objections on grounds of overdevelopment of site. Traffic generated by proposed development will result in an increase of highway danger owing to increased use of access and this is increased by parked vehicles along Post Office Road to visit nearby shop.

07/00183/FUL Detached dwelling and garage and demolition of semi detached cottages, 1 Home Farm Cottage, Crockington Lane - Strong objections on grounds of over-development and inappropriate development in the Green Belt. Proposed dwelling out of character with surrounding area and it is felt that the cottages should be retained. Skyline will be detrimentally affected.

07/00239/CAC Demolition of bungalows and erection of 2/3 storey buildings containing 5 no. apartments, Seisdon Road, Trysull - Strong objections on grounds of inappropriate development within a Conservation area and the proposed development is out of keeping with the surrounding area, particularly in view that this proposed development is next to the Red House, one of the most prominent listed buildings in the area, and will adversely affect this building. The Red House is given a glowing reference in the book The Buildings of England, Staffordshire, by Nikolas Pevsner, published in 1974.

Planning permission granted for 06/01289/FUL First floor side extension to 47 Post Office Road. Councillors very concerned that this will create an unfortunate precedent and question the reasons for this permission and why the 30% guidelines were not followed. Clerk to write to the Planning Office.

Concerns about large amounts of sand being excavated from Clive View, Bridgnorth Road, to Tarmac. Clerk to write to the Planning Office and request they investigate. Cllr. McCardle will also speak to the Planners.

### **Outstanding Planning Issues**
