Mr. Keeling has informed Cllr. Edwards that this narrow area will be concreted. **Clerk to write again to Highways.**

Signs/road markings, traffic calming areas

Additional road markings/signs are needed to highlight traffic calming areas.

Some signs need attention: Corner Seisdon Road by Meadow Cottage – de-restriction sign is sideways/ Sign at Ebstree Road bridge.

Village Hall - Posts on verge outside Village Hall have been knocked over/damaged. **Clerk to write again to Highways.**

Seisdon Road, Trysull - no kerb from the P.C. noticeboard to the Manor House. Dangerous to pedestrians.

Bridgnorth Road - lights at the Garden Village distracting. Cllr. McCardle has reported this.

Signs on the highway verge outside Gardenland Wyevale distracting and impeding visibility.

Trysull Holloway - village side of bridge, sluice valve tap cast iron cover is broken in the middle of the road. Highways informed.

Hungerford House, Seisdon Road - deep dangerous pot hole in front of dwelling.

Hollybush at Ebstree - large stones have been exposed at the base of the hedgerow past the Hollybush. Very dangerous and cars have been damaged by these. Highways informed.

The Gables, Seisdon Road - overhanging hedge in front of this dwelling is forcing vehicles into middle of road when turning left from Seisdon Holloway into Seisdon Road. Reported to Highways

Wombourne Road - Trysull Village entrance sign damaged.

Trysull Holloway/Ebstree Road - White railings on left hand side of junction damaged due to an accident. Clerk to forward details of the driver for insurance purposes to replace damaged railings.

Bridgnorth Road Manhole cover loose, surrounding tarmac breaking up. Situated by junction with Fox Road.

Ebstree Road Drains blocked with leaves from Seisdon Road to Crockington Lane. Clerk to inform Highways. **Clerk to write again to Highways.**

Feiashill Road, pot hole 20 yards on the left from traffic calming towards Swindon.
