PLANNING APPLICATIONS

10/00268/FUL & 10/00269/LBC Removal of hedge, erection of replacement fence, widening of driveway and installation of satellite dish (retrospective) Croft Cottage, School Road, Trysull. Dr. Cartwright declared an interest. There were objections to the height of the fence which is out of keeping with the surrounding area which is in a Conservation Area. There was originally a hedge and historic wall made of large boulders and the high fence which replaces this is
There were objections to the widening of the access which has changed the street scene from a traditional rural access to an open place which is out of keeping with this aspect of this Conservation Area.
