Mrs. Maggie Quinn was welcomed to the meeting. Mrs. Quinn wished to promote and talk about Connecting Communities, Local Connectors and Good Life Champions. There is a Good Life Connector covering the whole of South Staffordshire and also a Good Life Agent. Mrs. Quinn explained how Good Life Champions can assist in connecting communities and asked the Parish Council to consider nominating one or two volunteers from the Parish Council to liaise with the South Staffordshire Council and promote the Good Life web site. Mrs. Quinn asked Councillors to consider this with a view to discussing it at our next meeting. NEW HIGHWAY MATTERS

Concerns expressed regarding the deterioration of the road edges of Fox Road and Ebtree Road due to lorry damage. The Clerk instructed to request Highways to inspect these and carry out any necessary repair work.

The Clerk was instructed to request the cutting back of the overgrown bush on the highway verge at the junction of Seisdon Road and Ebtree Road.

PUBLIC PARTICIPATION

Concerns expressed regarding funds for maintenance work around the Parish when this work is the responsibility of the Highways Department. This is to be discussed when the budget figures have been calculated.

It was reported 117 lorries travelled through Seisdon in a period of 2.5 days. This has been reported to the County Council who state this is because Langley Road is closed.

It was reported that Aston lorries have come through the village full and uncovered. The Clerk was asked to write to Astons.

Concern was expressed regarding the amount of dog fouling on the playing field. Councillors agreed and stated this has been reported to SSC. SSC have given notices to the Council which have been designed by schoolchildren and two were given to Cllr. Harrison and two to Cllr. N. Compson to be put up in Trysull and Seisdon.

Fox Road - hedge on right hand side by traffic calming when approaching from Bridgnorth Road still needs to be cut back more severely in order to see oncoming traffic.

Woodford Road, Trysull (Enquiry 40446 25) Pot holes reported. Site has been assessed.

Union Lane, Trysull (Enquiry 4044624) Pot holes outside Awbridge Farm, Flash Lane and Blackpit Lane. Site has been assessed.

Ebstree Road - 'give way' sign missing by the Smithy. This has been reported.

Wombourne Road (Enquiry 4060863) Trees and hedges overhanging Wombourne Road from Bratch Farm to Union Lane need to be cut back to prevent damage to vehicles and assist visibility.
