Playing Field, Trysull and Seisdon

Fencing at Seisdon Playing Field has been vandalised again. Mr. Tonkinson has been in touch with the SSC and a risk assessment has been carried out. SSC have stated that a cattle fence can be erected. Mr. Tonkinson will deal with this matter. Mr. Patrick, Trysull Tigers, has been given copies of the letter with the Police telephone number to circulate to parents.
