MINUTES OF MEETING

The Minutes of Meeting dated 8th September 2010 were agreed and signed as a true record.
Planning Minutes of Meeting dated 28th September 2010 were agreed and signed as a true record.

PLANNING APPLICATIONS

10/00801/FUL Satellite dish, new hedgerow and widening of existing driveway (retrospective), The Croft, School Road, Trysull – The Parish Council object to this retrospective application. Object to the removal of the hedge and part of the historic wall which was made with large stones and a replacement hedge should be planted on the original line as before. Strong objections to the widening of the access which has changed the street scene from a traditionally rural access to an open area which is out of keeping with this aspect of the Conservation Area.

10/00800/FUL New access and new detached dwelling with garage, The Croft, School Road, Trysull, The Parish Council have taken into account your refusal of a similar application in the area and feel they should concur with your decision and therefore object to the proposed erection of a detached dwelling and garage. The Parish Council question the requirement for nine car parking bays and we object to that number of vehicles using the proposed new access onto School Road. This proposed dwelling would be in close proximity of 4 White Row and would appear bulky for the occupants of No. 4 and be dominating and oppressive when the residents are in their garden and conservatory. The siting of the proposed dwelling would be harmful to the living conditions of residents of No. 4.

ANY NEW BUSINESS

It was reported that the Post Office in Wombourne is moving to School Road where there is very little parking. It was agreed that the Clerk will write to Gavin Williamson M.P. stating it is a major hardship on our residents not to have a Post Office. Clerk to enclose copy of our report when fighting the Post Office closure and to inform Mr. Williamson M.P. Councillors would be pleased to meet with him to discuss this.

Trysull School have requested the grit bin on the car park be re-filled. Clerk to e-mail the Area Surveyor asking whether the bins in the Parish are to be filled before the bad weather.

The Chair, Vice Chair, and Mr. Tonkinson met Mr. David Wright and Mr. Brian Wilding (Highways) and visited several sites in the Parish. It was felt this was very beneficial and the Clerk is to write and thank them for their assistance. Items discussed will be reported in the relevant minute.

Mr. David Wright has reported a new scheme regarding funding for jobs needed in the Parish and he will forward details.

It was reported that Highways and Police do not deal with weight restriction offences and this is now dealt with by Weights and Measures, SSC.
