This request can be listed for consideration under the local members divisional highway programme.
- 2654 Stencilling dog signs
Cllr. Neil Compson has spoken to Mr. Littleton about dog fouling but disappointingly it would appear the District Council are unable to take action.
- 2658 Drains, Ebtree Road
Continue to wait for gullies on Ebtree Road to be cleaned. Clerk to e-mail again stating weather deteriorating and leaves will be present.
- 2660 SID sign on Ebtree Road
Request for SID sign by Lanes Farm. E-mail received from Mark Keeling stating he will speak to Cllr. Edwards and keep us informed with regard to any progress with our request.

- 2677 Weight Restriction Request - Seisdon Holloway
Mark Keeling will list the request for a weight restriction via the County Councillors Divisional Highway Programme 2017/18 and the information will be entered onto their database. . It was suggested monies be allocated from the Precept for signage.
Cllr. Smith stated he would speak to Cllr. Edwards.
- 2678 Resignation of Councillor and Co-option
This item was discussed at the start of the meeting and the Clerk reported there has been no request for an election. Two candidates have asked to be considered for co-option and it was agreed discussions will be held in committee. Discussions were held and a vote taken resulting in Mrs. Corinne Lowe 3 votes and Mr. Andrew Hingley-Smith 2 votes. Clerk to notify Mrs Lowe and forward October minutes and agenda for the November meeting.
A complaint was received from Mr. Hingley-Smith stating the co-option should not have been decided in committee and co-option was not on the agenda. The Clerk was asked to seek the advice of South Staffordshire Council Legal Department and forward this information to Councillors and Mr. Hingley-Smith.
- 2679 Police Accountability Forum
Wednesday 2nd November at 5.00 p.m. at Wombourne Police Station. It was stated that Mr. Merrick will attend.
- 2680 Bridge over Mill Stream, Post Office Road
E-mail received from Mr. Purdell, SSC., stating investigations will be carried out to find root cause of the settlement and repairs will be carried out to improve the pot hole situation.
- 2681 Overgrown bushes, Post Office Road
It was reported bushes have been cut back. Councillors thanked Mrs. Lui for arranging this and the Clerk was asked to write to the residents thanking them for their assistance.

Cllr. Harrison stated he has tidied up around the bridge. Cllr. Neil Compson suggested precepting for a person to carry out maintenance work around the Parish.

Oak Drive payment

Pavement Engineer to assess footway and put it forward to a Structural Maintenance programme. Clerk to request for an update.

Wombourne Road (4014672) Bollards broken on bend between Union Lane and Ovens End.

Wombourne Road - Village entrance sign has been added to Cllr. Edwards' DHP for future consideration.

Fox Road - hedge on right hand side by traffic calming when approaching from Bridgnorth Road still needs to be cut back more severely in order to see oncoming traffic.

Post Office Road, manhole cover outside Lilac Cottage, Post Office Road where the tarmac is crumbling and coming away making the manhole cover unstable. Clerk has informed Highways.

Woodford Road, Trysull (Enquiry 40446 25) Pot holes reported. Site has been assessed.

Union Lane, Trysull (Enquiry 4044624) Pot holes outside Awbridge Farm, Flash Lane and Blackpit Lane. Site has been assessed.

Ebtree Road - 'give way' sign missing by the Smithy. This has been reported.

Union Lane - blocked gully outside Awbridge Cottage reported to Highways Hotline.
