ANY NEW BUSINESS

Mr. Compson to arrange safety inspections at the Village Hall and Pavilion.

Report received that bus shelter on Feiashill Road needs to be weeded. Mr. Tonkinson to request A.M.S. Ltd. to carry out this work.

Mr. Compson stated that the Chairman's board needs updating and he will arrange this.

Dr. Cartwright reported that the stile on Footpath 7 exiting onto Crockington Lane is very overgrown and walkers are unable to use it. Clerk to inform Footpaths Department requesting that the necessary work to be carried out.

It was reported that there is mud and weeds growing over the drains along Ebtree Road and the Clerk was asked to inform Highways about this and Post Office Road drains.

It was reported that Mr. Wright had previously stated a survey was needed to look at the drainage system in Ebtree Road because of the flooding and the stream. Clerk to ask whether a survey has been carried out and if so the conclusions.

The hedge along Fox Road by the traffic calming needs cutting back as there is no visibility towards Seisdon and on-coming traffic cannot be seen. The hedge is encroaching onto Fox Road and the safety bollards are being covered. Clerk to inform Highways.

It was reported that visibility to the right from Swindon on the Smestow junction is bad because of the overgrown hedgerow. Clerk to inform Highways.

Clerk to inform Highways that trees along Ebtree Road are overhanging onto the pavement and pedestrians have to step 2 ft. into the road. Road safety issue.

Councillor Edwards felt it would be beneficial for Councillors to meet Mr. David Wright and visit problem sites in the Parish. Councillor Edwards stated he would ask Mr. Wright to get in touch with Clerk. Clerk to write to Mr. Wright.

Councillor Edwards stated that Enville and Bobbington Parish Councils were discussing the possibility of purchasing a moveable interactive sign and the Clerk was asked to get in touch with the Enville Clerk stating this Parish Council would be like to discuss this with them.

The Clerk was asked to write to the SSC stating that if another marathon is arranged then there must be earlier notice in order that residents can be informed.
